# NEW SOUTH WALES BRIDGE ASSOCIATION ANNUAL GENERAL MEETING

## Wednesday 21 December 2016

## 1. Opening

The Secretary of the NSWBA declared that a quorum was present. It was noted that the Chairman of Council was not present and that in accordance with Article 16 of the Articles of Association it was necessary to appoint another member to chair the meeting.

Motion (Richard Douglas/John McIlrath) That John Scudder take the chair.

Motion carried.

John Scudder took the chair and declared the meeting open at 6.35 pm.

Apologies were noted from Julian Foster, Helena Dawson, Inez Glanger, Bob Sebesfi and Terry Brown.

## 3. Confirmation of Minutes of meeting of 2015 Annual General Meeting

Motion (John Scudder/David Beauchamp) *That the circulated minutes of the previous Annual General Meeting held on Wednesday 9 December 2015 be accepted as a true and accurate record of the proceedings of the meeting.*

A video prepared by the Chairman of Council was shown. He drew attention to the work that had been done on segmenting financial information between the activities of the premises, events, the Sydney Bridge Centre sessions, and activities in relation to the role of the NSWBA in administering bridge in NSW.

He also drew attention to the proposal to adopt a new constitution. He pointed out the need for a number of technical changes to bring the constitution up to date.

Motion (John Scudder/Richard Douglas): That the Company's current constitution (being the Memorandum and Articles of Association of the New South Wales Bridge Association Limited both dated 18 October 1963, and as amended) be replaced in its entirety by a new form of Constitution as circulated.

Motion carried with a 75% majority.

It was noted that two Councillors were retiring at this meeting. Cath Whiddon has contributed significantly to the Association's activities in promoting teaching and education. Sophie Ashton has helped to revitalise Monday evening sessions by extra promotion and by arranging for our top players to give talks prior to some sessions.

Cath and Sophie were thanked for their efforts.
